RECOMMENDATION ON SUPPLEMENTAL ALLOCATIONS TO
GREECE AND CZECHOSLOVAKIA FOR MILK CONSERVATION ASSISTANCE

GREECE

1. The original apportionment to Greece for milk conservation assistance was \$100,000 of the \$2,000,000 set aside for UNICEF assisted milk conservation programmes in Europe (E/1114/para.14). It was further agreed that any unprogrammed balances in country allocations might be used for this project, but in Greece none have been available for this purpose. The actual cost of the equipment for Greece would have been \$100,000 based on the then current rates of exchange for the pound sterling currency which was used in procuring the supplies. However, most of the equipment was procured with sterling received by the Fund prior to devaluation and recorded in resources at predevaluation rates of exchange. Consequently, the equivalent U.S. dollar cost of equipment to the Fund has been \$130,000. Since there are insufficient unprogrammed balances in the total allocations to Greece to cover this increased cost, the Administration recommends that an additional allocation of \$30,000 out of the still existing MCP reserve of \$35,000 be allocated to Greece to cover this increased cost. This additional amount would result in a total allocation for Greece of \$130,000 for MCP.

CZECHOSLOVAKIA

2. The original special allocation to Czechoslovakia for a milk conservation programme was \$180,000. In addition Czechoslovakia has set aside \$114,000 for milk / conservation programmes

conservation programmes from the regular block allocations made to this country by the Executive Board. Due to the fact that the first UNICEF milk drying plant to be erected in any country was located in Czechoslovakia, many unavoidable construction difficulties in this initial operation resulted. Consequently the costs of the imported construction team required for erecting the milk conservation programme plants have exceeded the original estimates owing to a prolongation of the construction period; however, the plant is now in operation. The Administration recommends that the balance of the MCP reserve of \$5,000 remaining after the previous apportionment to Greece be allocated to Czechoslovakia to cover the additional construction costs because there are no further unprogrammed balances in the Czechoslovakian programme.
