Paper compiled by a Working Group of the Committee. Observations on family and its individual members; on family functions; on structures in society and their relationship to family.

### **\* Family in Crisis - Spring 1987**

Paper compiled by a Working Group of the Committee, dealing with definitions, functions of the Family, problem areas and possibilities to cope with them.

### **\* An International Year of the Family - NGO Opinions - 1988**

Prepared by the representative of IFSW with assistance of the representative of the International Secretariat. Synthesis of 37 responses of national and international NGOs to a questionnaire of the Committee, requesting reactions to the idea, whether positive or negative, and for suggestions as to how to celebrate and implement a possible International Year of the Family.

### **\* Basic Tenets for Strengthening Families - 1990**

Paper compiled by a Working Group of the Committee as basis for discussions and actions of NGOs on family questions.

### **\* Checklist of Activities for an effective IYF - 1990**

Compiled by a Working Group of the Committee. Tool for planning IYF actions. The Checklist consists of seven "lists" each one directed for a "check" of possible activities at a specific area/structure. (The Checklist is available in English, French, Spanish, German and Portuguese.)

**\* National Coordinating Bodies for the IYF - 1990**

Prepared by one of the member organizations of the Committee. Discussion paper, including suggestions on how to stimulate national level actions to prepare for the IYF.

**\* Guiding Principles on the Family - 1993**

Developed by a Working Group of the Committee. The paper outlines a possible text for a declaration of rights and responsibilities of families. (The document is available in English, French, Spanish and German)

**\* Family - a Topic for International Debate and Action - 1991**

Proceedings of a Seminar organised by the Committee. The IYF was in the center of discussions, various panels dealt with NGO observations, expectations of family members, contributions to the IYF from different parts of the CSDHA. (US-\$ 20,-)

**\* "Families International" - International Newsletter**

This information document was launched by the Committee in 1989. It is published 3 - 4 times a year (9 issues May 1989 - January 1992). It features NGO activities; information on programmes and services; research projects concerning families; UN news; information on conferences and special events; etc. The newsletter is compiled and edited by the representative of IFSW and distributed globally.

**\* Profile of the NGO Committee on the Family - 1992**

(3<sup>rd</sup> Edition). Document provides information on objectives, functioning, members, resources and activities of the Committee.

**\* Family and Environment: A Partnership - 1993**

Proceedings of the 4th Seminar organized by the Committee. The Seminar focused on the relationship between environment and family thereby building a link between the Conference in Rio and the IYF. (US-\$ 20,-)

**\* Organizing Events within and around the IYF 1994 - 1993**

This document is a tool for integrating IYF objectives and concerns into national and local social events.
